- 4. The tender/Sealed Bid/offer will be opened in the presence of the Authorized Officer.
- 5. Date of Inspection of the Immovable Property is on 21-05-2022 between 11.00 AM to 04.00 PM.
- 6. The Earnest Money Deposit (EMD) of the successful bidder shall be retained towards part sale consideration and the EMD of unsuccessful bidders shall be refunded. The Earnest Money Deposit shall not bear any interest.
