Tenders that are not filled up or tenders received beyond last date will be considered as invalid tender and shall accordingly be rejected. No interest shall be paid on the EMD.

- 5. The tender/Sealed Bid/offer will be opened in the presence of the Authorized Officer.
- 6. Date of Inspection of the Immovable Property is on 15.05.2023 between 11.00 AM to 04.00 PM.
- 7. The Earnest Money Deposit (EMD) of the successful bidder shall be retained towards part sale consideration and the EMD of unsuccessful bidders shall be refunded. The Earnest Money Deposit shall not bear any interest.
