- 2. Last Date of Submission of Tender/Sealed Bid/Offer in the prescribed tender forms along with EMD and KYC is **29-03-2022 TILL 5 PM** at the Branch Office address mentioned herein above. Tenders that are not filled up or tenders received beyond last date will be considered as invalid tender and shall accordingly be rejected. No interest shall be paid on the EMD.
- 3. Date of Inspection of the Immovable Property from 24/03/2022 between 11.00 AM to 1.00 PM.
- 4. Date of E-Auction for Property is **30-03-2022** at the web portal <u>https://sarfaesi.auctiontiger.net</u> from **12:30** PM to **1:30** PM with unlimited extensions of 5 Minutes each.
- 5. The Earnest Money Deposit (EMD) of the successful bidder shall be retained towards part sale consideration and the EMD of unsuccessful bidders shall be refunded. The Earnest Money Deposit shall not bear any interest. The successful bidder shall have to deposit 25% of the sale price, adjusting the EMD already paid, immediately after the acceptance of bid price by the Authorized Officer and the balance 75% of the sale price on or before 15thday of sale or within such extended period as agreed upon in writing by and solely at the discretion of the Authorized Officer. - 12. Further interest will be charged as applicable, as per the Loan Agreement on the amount outstanding in the notice and incidental expenses, costs, etc., is due and payable till its realization.
