Tenders that are not filled up or tenders received beyond last date will be considered as invalid tender and shall accordingly be rejected. No interest shall be paid on the EMD.
- 3. Date of Inspection of the Immovable Property from 25-March-2022 between 11.00 AM to 1.00 PM.
- 4. Date of E-Auction for Property is **30-March-2022** at the web portal <u>https://sarfaesi.auctiontiger.net</u> from **12:30 PM to 1:30 PM with unlimited extensions** of **5 Minutes each**.
- 5. The Earnest Money Deposit (EMD) of the successful bidder shall be retained towards part sale consideration and the EMD of unsuccessful bidders shall be refunded. The Earnest Money Deposit shall not bear any interest.
