**The Ter**ms and Conditions of the E-Auction are as under:

- 1. E-Auction is being held on "AS IS WHERE IS BASIS", "AS IS WHAT IS BASIS", and "WHATEVER IS THERE IS BASIS" and will be conducted "Online". The Auction will be conducted through the ABHFL approved auction service provider "e-Procurement Technologies Ltd | Auction Tiger"
- 2. Last Date of Submission of Tender/Sealed Bid/Offer in the prescribed tender forms along with EMD and KYC is 09-June -2022 TILL 5 PM at the Branch Office address mentioned herein above. Tenders that are not filled up or tenders received beyond last date will be considered as invalid tender and shall accordingly be rejected. No interest shall be paid on the EMD.
- 3. Date of Inspection of the Immovable Property from 02<sup>th</sup>-June -2022 between 11.00 AM to 1.00 PM.
- Date of E-Auction for Property is 10-June-2022 at the web portal <u>https://sarfaesi.auctiontiger.net</u> from 12:30 PM to 1:30 PM with unlimited extensions of 5 Minutes each.
- 5. The Earnest Money Deposit (EMD) of the successful bidder shall be retained towards part sale consideration and the EMD of unsuccessful bidders shall be refunded.
