- 4. The tender/Sealed Bid/offer will be opened in the presence of the Authorized Officer.**
- 5. The Earnest Money Deposit (EMD) of the successful bidder shall be retained towards part sale consideration and the EMD of unsuccessful bidders shall be refunded.
