1. **Last Date of Submission of Tender/Sealed Bid/Offer** in the prescribed tender forms along with EMD and KYC is **28.04.2023 up to 5:00 PM** at the Branch Office address mentioned herein above. Tenders that are not filled up or tenders received beyond last date will be considered as invalid tender and shall accordingly be rejected. No interest shall be paid on the EMD.

3. The tender/Sealed Bid/offer will be opened in the presence of the Authorized Officer.
4. **Date of Inspection of the Immovable Property** is **on 27.04.2023** between **11.00 AM to 04.00 PM.**
5. The Earnest Money Deposit (EMD) of the successful bidder shall be retained towards part sale consideration and the EMD of unsuccessful bidders shall be refunded.
