This is in reference to our letter dated August 18, 2021 on intimation of payment obligations [Erstwhile Reg. 50(1)] and record date inter alia for NCDs [(Regulation 60(2))], where we had intimated the interest payment date of ISIN No. INE831R08084 as January 17, 2022 (the actual payment date i.e. January 15, 2022 is a Saturday and a non-business day as per the offer document issued by the Company).

We would like to inform you that as per the Securities and Exchange Board of India (Issue and Listing of Non-Convertible Securities) Regulations, 2021 and Operational Circular for issue and listing of Non-Convertible Securities, Securitised Debt Instruments, Security Receipts, Municipal Debt Securities and Commercial Paper dated August 10, 2021, interest/redemption payments falling on a working Saturday when there is no Bank holiday (1st, 3rd and 5th Saturdays of the month), will have to be paid on the same day.
